PROJECT DESCRIPTION

The project will include 3 intersection treatments in the North Battleford and Battleford areas. Including the following:

- The construction of a left turning lane on Highway 16 to Hereford Street
- The construction of right turning lane on Highway 4 to 22nd Street
- The construction of right turning lane on Highway 4 to 29th Street

PROJECT DETAILS

- The Contract Number for this project is H25067.
- The Contractor for this project is G&C Asphalt.
- The Contractor's address as indicated on the bidder's signing block is North Battleford, Saskatchewan.
- Contract supervision will be provided by Associated Engineering personnel.
- Work to begin the week of September 22, 2025, on Highway 4 and will be ongoing for three weeks. Work on Highway 16 may begin this construction season depending on weather.
- Traffic Accommodation will be in effect reducing speed to 60 km/hr and will have one lane closed on the highways during construction.
- The estimated total cost of this project is \$1.3 million, including materials, construction engineering, and PST.
- This is a Capital Program project in the Central Maintenance Region.
